

1. APPLICATION FOR TURKISH ID CARD

Conditions for application:

1. **In-person application with an appointment** on www.konsolosluk.gov.tr is required for those who are over 18 years old.
2. Those between the ages of 15-18 have to apply **in person with** their mother or father or legal guardian, by **getting an appointment**.
3. For those who are under 15 years old, mother or father can apply **in person with an appointment**. In case of divorce, only the person who has custody of the child can apply for Turkish ID on behalf of the child.

Applications via mail are not accepted.

Required documents:

1. Application form (Encl.)
2. Turkish ID (nüfus cüzdanı)
 - a. If lost, it is obligatory to submit original and a copy either Turkish marriage certificate (uluslararası aile cüzdanı) or passport or driver's license.
 - b. If photo of the current Turkish ID is not similar to your current look or you have not had any Turkish ID with a photo on it, you must bring additional photo IDs.
3. One (1) biometric photo, taken within the last six (6) months (*Background: White*)
4. ID of the custody holder, along with its photocopy if the applicant is under 18.
5. Another photo ID for the applicant between the ages of 15-18

Fee:

Turkish ID Card fee: \$ 8,39

Application due to loss of Turkish ID Card: \$ 12,79

Additional information:

Application fee can only be paid in cash. Personal checks are not accepted.

For those who are under 15, there will be no photos on the IDs. However, upon request, it is possible to add photo of the child. Those who are between the ages of 15-18 **have to apply in person with their mother or father or legal guardian**.

Those, who are under 15, shall not give biometric data (fingerprint, etc.)

How to receive your Turkish ID Card:

Turkish IDs cannot be issued upon application. Once you apply, you will be given a temporary ID, which will be valid until you pick up your new Turkish ID Card. When your new Turkish ID Card will be mailed to our Consulate General, you will get an e-mail. You have **3 options to receive your Turkish ID Card**. Please let the Consular Officer know which option you prefer during your transaction.

- 1- You can pick up your Turkish ID Card in person with your application form (*)
- 2- You can authorize someone to pick up your Turkish ID Card in person with your application form. (*)
- 3- You can send us a prepaid return envelope along with your application form. (*) We will mail your ID back to your address in the prepaid return envelope.
