16. DIGITAL NOMAD VISA APPLICATION PROCESS

A citizen of a foreign country, who wishes to work in Türkiye as a digital nomad, must enter Türkiye on a Digital Nomad visa. You can apply for that visa at the nearest Turkish mission to your residence.

Application Method:

- 1. Make your pre-application on https://digitalnomads.goturkiye.com/
- 2. Get your pre-application form with a QR code and print it. (*Requirement #8*)
- 3. Gather the required documents listed below.
- 4. Start an online application on <u>www.visa.gov.tr</u> and upload the documents when prompted.
- 5. Print out the application form. (*Requirement #2*)
- 6. After submitting the application successfully, schedule an appointment for the interview.

Applicants are required to bring hard copies of the documents on the day of the interview as well.

Required documents:

- 1. National passport and a copy of the ID section
 - a) with an expiration date at least 60 days beyond the last day of your intended stay.
 - b) with a blank page to affix the visa.
- 2. The application form
- 3. One recent passport photo size (2" x 2")
- 4. Original and the copy of your green card or your valid US visa. (For NON-US applicants only)
 - Valid I-20 or the letter from school is required for the student visa holders.
 - B1/B2 visa holders can only apply at their country of residence.
- 5.Diploma of the university degree and its copy
- 6. Pre-application form with a QR code (obtained from https://digitalnomads.goturkiye.com/)
- 7. If the digital nomad works for a company, the contract signed by both parties.

8. If the digital nomad is a freelancer, official letter from the company stating details of the project s/he works on.

9. Certificate of good conduct that can be obtained from your local police department.

10. Proof of lodging.

• If you are going to be hosted, a notarized invitation letter must be submitted.

11. Flight reservation indicating your intended travel dates. (These reservations do not need to be purchased yet)

- 12. Most current bank statement under your name.
 - If you are going to be sponsored for your education, a letter and a bank statement of your sponsor must be submitted.
- 13. Proof of travel health/accident insurance, valid through duration of stay, including:
 - a) minimum coverage of 30,000 Euros or equivalent USD

b) transfer of the patient to nearest healthcare facility or residency address after discharge and transfer of body in case of death,

- 14. Non-refundable visa fee
 - Visa fees can only be paid in cash or as money order payable to Turkish Consulate General. Debit, credit cards, or personal checks are not accepted.

15. A pre-paid envelope (mail carrier of your choice) if you would like your visa-issued passport to be returned by mail. (*The Consulate General is not responsible for any delivery issues*)

Important notes:

- In individual cases, you may be required to provide additional documents.
- After making your pre-application, you must get your appointment at the Consulate General in 30 days.
- Processing the visa application after the interview may take up to 30 days. You are advised to apply accordingly.
- The Consulate General cannot expedite a visa application.
